


What your bequest will mean to Fraser Coast Hospice


The ability of the Fraser Coast Hospice to meet the financial challenges of providing quality palliative care services for the community in the years ahead depends very much on the generosity of people like you.

Providing fee free care for terminally ill people on the Fraser Coast in the last days and weeks of their life.

About Us

Fraser Coast Hospice is a 6 bed purpose built inpatient facility, providing palliative care for terminally ill people over the age of 18 years on the Fraser Coast.

Palliative care is person and family-centered care provided for a person with an active, progressive, advanced disease, who has little or no prospect of cure and who is expected to die, and for whom the primary goal is to optimise the quality of life.

Hospice care is a type of health care that focuses on the palliation of a terminally ill patient's pain and symptoms and attends to their emotional and spiritual needs at the end of life. Hospice care prioritizes comfort and quality of life by reducing pain and suffering.

We provide our service fee-free. We have no set visiting hours, allowing families to come and go as they please. We encourage and allow pets to visit.

All clients must have a doctor admit them and see them regularly during their stay and each shift across 24 hours we have a Registered Nurse and Personal Care Assistant providing care and support to keep clients comfortable.

We can't do it without you.....

Funding to employ highly trained staff is needed to ensure our palliative care services can remain accessible to everyone.

Your financial support will supplement our funding, allowing us to provide a comprehensive palliative care program.

Making a Bequest

A bequest is a gift made through a Will, and a true statement of your commitment and concern for others.

You may wish to make your bequest to Fraser Coast Hospice in the following ways:

The Residue

When you have provided for your family and friends you may wish to leave the residuary estate (what is left) to the Fraser Coast Hospice.

Suggested wording:

I GIVE to the FRASER COAST HOSPICE ASSOCIATION INC. for its general purposes, free of all duties, the rest and residue of my Estate and I DIRECT that the receipt of the Treasurer or other proper Officer of the Association shall be sufficient discharge to my Executor.

A Percentage

You may decide to share your estate between a number of people and charitable organisations. Stating a percentage for each one allows for inflation or possible changes in your estate.

Suggested wording:

I GIVE to the FRASER COAST HOSPICE ASSOCIATION INC. for its general purposes, free of all duties, _____% of my Estate and I DIRECT that the receipt of the Treasurer or other proper Officer of the Association shall be sufficient discharge to my Executor.

A Specific Bequest

You may wish to state a specific sum of money, and for a specific purpose.

Suggested wording:

I GIVE to the FRASER COAST HOSPICE ASSOCIATION INC. for its general purposes, free of all duties, the sum of \$ _____ and I DIRECT that the receipt of the Treasurer or other proper Officer of the Association shall be sufficient discharge to my Executor. I REQUEST that this gift be applied by the FRASER COAST HOSPICE ASSOCIATION INC. for the purpose of _____.

A Bequest of Property or an Asset

You may also wish to leave property, works of art or other assets from your estate.

Suggested wording:

I GIVE to the FRASER COAST HOSPICE ASSOCIATION INC for its general purposes, free of all duties,

- The property at _____ described as _____
- My shares / debentures _____
- Other (details) _____

and I DIRECT that the receipt of the Treasurer or other proper Officer of the Association shall be sufficient discharge to my Executor.

NB: These are suggested clauses only and you should consult your Solicitor regarding the specific provisions of your Will.
